How long we keep it: We will keep your basic personal data for two years after your last EUSR registration expires, after which time it will be destroyed.

What are your rights? If at any point you believe retained information is incorrect you can request to see this information and even have it corrected and possibly deleted. Providing you this information is free of charge, but charges may apply for excessive requests.
